Shooting fees:

Wounded game will be calculate. Price depends on the shooting situation and the price will agreed with the Seller on the spot. Missing shoot will not be calculate.

The package price excludes the follows that will be paid on the spot for the Seller by the guests:

- Transfer from the airport
- Shooting fees
- Trophy fees for preparing
- Trophy fees for the transport (extra weight, fee for the vicinity etc.)
- Alcoholic drinks, gratuities, personal expenses

Home transport of the trophy:

It will be agreed on the spot with the Seller, it depends on the quantity of the trophies.

List prices and the possibilities:
